Another summer season is upon us and the lake will soon be buzzing with activity. I have thrown together a few items to get the year off on the right foot. Welcome Back!

Water levels

This winter provided very little precipitation to our area. Since our lake is a "seepage" lake the water level is a result of runoff water and ground water. As of April 29th the lake is down 9.6" compared to the same date as last year. We have an additional 6-8 ft of beach on the south shore. Launching our boat was not a problem.

Boat Landing

The concrete pads at the boat landing experienced severe buckling this winter. I think it was natures way of keeping cars and trucks off the ice. The town was quick to fix this issue soon after the ice was gone. The the landing is ready for you to launch your boats. Remember as you move your watercraft in and out of the lake to remove all weeds from the watercraft and trailer. Any bilge water or live well water must also be emptied.

Milfoil Status

The lake association continues to work on managing invasive species in our beautiful lake. Milfoil is our biggest concern. This rapidly spreading non-native plant is a problem throughout Wisconsin. Because the association has been vigilant on this issue for over 15 years we have kept the density down. This winter the lake association applied for another DNR grant to help us meet our management goals for 2024. Unfortunately we did not receive the grant. We ended up being one step below the cut off. We are still waiting for final word from the DNR on why we did not received the grant. Our lake

management consultant Onterra believes it is mainly do to the fact that the severity of our infestation is much lower than many others. This means there will be no treatment to control the milfoil this summer. It also means we will need to develop alternative funding sources if we wish to keep milfoil under control. Milfoil is here to stay and must be managed in order to keep it from making the body of water unusable. Please join us for a discussion on this topic at the annual meeting.

Annual meeting

The annual meeting of the BLPOA will be held at the Northern Grace Youth Camp on May 25th at 9:00 AM. We will have a presentation on the milfoil status from our AIS committee, discussion on funding milfoil treatments, voting on new board members and an overview of social activities for 2024

Burning Brush

It is important for all property owners to keep up to date with the current burning restrictions in the area. The lack of precipitation this winter has created dangerous fire conditions. Hopefully we start to get some rain soon and the plants can green up. Before burning you should get a "free" burning permit and check the current restrictions.

BOATING/PERSONAL WATERCRAFT OPERATION (PWC)

- All watercraft are to observe a slow no wake speed from 8 PM or Sundown (whichever comes first) until 10 AM everyday, and must be in a COUNTER-CLOCKWISE direction.
 - Slow No Wake 2024
 Ice off June 3rd = Sunset
 June 4th August 13th = 8 PM.
 August 14th to ice on = Sunset
- All persons in the boat must have an approved flotation device
- It is unlawful to operate a motorboat within 100 feet of any dock, raft, pier, or buoyed restricted area at a speed in excess of "slow-no-wake"
- PWCs must be at a slow-no-wake speed whenever within 200 feet of the shoreline
- Motorized crafts must yield the right-ofway to all sailboats and other nonmotorized crafts
